## PINGELLY BUSINESS SPOTLIGHT

During the COVID-19 Pandemic our local businesses are demonstrating incredible resilience and creativity in altering how they serve the community. ### **Pingelly-Brookton Community Bank Branches**

The Pingelly branch remains open with hand sanitiser upon entry and social distancing in place when interacting with staff. All services are available online, except access to passbook saving accounts. ### Arola's Café and Bakery

Arola's Cafe & Bakery are still providing the same menu in a takeaway format, but with also the option to purchase takeaway meals in bulk at a discounted rate. Orders and payment can be made over the phone, and the team are also providing a home delivery service for FREE. For those still entering the shop, strong social distancing measures have been introduced and the fridges have been moved to limit movement. #### **Pingelly Exchange Tavern**

Access to the Exchange Hotel is via the Quadrant Street door with a takeaway service available. Social distancing measures are in place to limit the number of people inside at one time. The main bar will be temporarily inaccessible during the pandemic.
