COVID-19 | ENTERING PHASE 2

Local Governments can re-open libraries, recreation centres and other community facilities with restrictions from May 18, under the COVID-19 WA roadmap released over the weekend by the Premier, Mark McGowan. The four phase plan was developed with reference to the National Cabinet framework, taking into account the best health advice for our state. WA is already effectively at Phase 1.

Phase 2 begins on Monday, 18 May and includes:

- indoor and outdoor non-work gatherings lifted to 20 people
- people are encouraged to return to work, unless they are unwell or vulnerable
- cafés and restaurants can reopen with meal service (including pubs, bars, clubs, hotels and casino), limited to 20 patrons and the four square metre rule applied
- weddings and funerals, limited to up to 20 attendees (30 for outdoor);
- places of worship, community facilities and libraries to re-open, limited to 20 patrons
- community sports (non-contact) limited to 20 people
- outdoor or indoor fitness classes (minimal shared equipment) limited to 20 participants

Regional travel restrictions are also being eased with travel permitted:

- between the South-West, Great Southern, Wheatbelt, Perth and Peel regions
- between the Mid-West, Gascoyne and Pilbara regions (excluding Biosecurity zone)
- within the Goldfields-Esperance region (excluding the Biosecurity zone)
- within the Kimberley Local Government Areas (the Commonwealth's Biosecurity zone remains in place).

Phase 3, which will commence around four weeks after the commencement of Phase 2, will involve further easing of restrictions on non-work gatherings, contact community sport, beauty therapy and personal care services, auctions, public playgrounds, skate parks, cinemas, museums, zoos, galleries and concert venues.

OUR WAY FORWARD IN PINGELLY

From Monday, 18 May 2020, businesses, community groups and facilities will reopen at their discretion based on individual circumstances. For individual operating hours it's recommended to contact the community group or local business directly, or check their Facebook page for current information.

The lifting of regional travel restrictions may see visitors from the Perth Metropolitan Area, as well as Peel, South West or Great Southern regions pass through our community toward their onward destination.

During Phase 2 it's important to continue social distancing (1.5m) and practising good hygiene to keep Pingelly safe.
