MEMORIAL PARK REFERENCE GROUP

The Shire of Pingelly is calling for expressions of interest from community members to join the Memorial Park Reference Group to help shape the detailed design for the Park.

The Reference Group will include 2 Councillors and up to 6 community volunteers with an active interest in the delivery of the project. The primary role of the Reference Group is to have input into the detailed design of the precinct. These elements are proposed in order to activate the centre of the town, and provide an attraction for both the community and visitors to the town. Representatives will be asked to attend 3 meetings throughout October and November in the first instance.

Where there is more expressions of interest than positions available, members of the Group will be selected based on their interest in the key elements of the proposal, and ideally will represent a diverse demographic.

Expressions of interest should be submitted by 30 September 2020, with nomination forms available on the Shire website, via email request to admin@pingelly.wa.gov.au or from the Shire office.

TOWN HALL

At the Town Hall workshops in July 2020, three options for the use of the Town Hall were developed by those in attendance.

- Undertake community based historical projects to capture and display the Town's diverse history on the wall spaces and potentially the stage area utilising photos, physical displays and audio-visual displays. Regularly rotate the displays to provide variety and ongoing dialogue for residents, visitors and tourists. Initial displays were suggested as including the Higgins War Photos, selected historical records, aboriginal culture/history and an agricultural display.
- A flexible space in the central hall space, focused on rotations of art and craft, workshops, additional historical displays, community pop up markets and stalls, tourism or community events.
- Incorporate a Tourism / Visitors Centre at the front of the Hall in a converted kitchen space.

The attendees at the workshops felt that all three options could co-exist in the Hall, utilising the stage, the main hall space, and the front kitchen.

This direction was endorsed by Council at its September meeting, subject to a final opportunity for community comment. Any further comment on the outcomes of the community workshops are invited, with submissions closing on 7 October 2020.

COUNCIL DECISIONS

Proposed Policy - Christmas Closure

Council adopted a Christmas Closure Policy to govern the annual administration closure, in order to eliminate the requirement for an annual item to Council on this matter.

Future Use of Pingelly Town Hall

Council endorsed a direction for the future use of the Pingelly Town Hall following a period of public consultation.

Memorial Park Project

Council selected representatives to be a part of the Memorial Park Project Reference Group and endorsed the commitment of up to \$40,000 prior to formal notification of the grant funding outcome, to minimise other project risks that are arising due to time constraints.

Addition to Schedule of Fees and Charges

Council endorsed the inclusion of fees for the Pingelly Gift Cards, and Tutanning Accommodation in the Schedule of Fees and Charges.

Asset Management Planning

Council endorsed a direction for the calculation of asset management renewal requirements over the next 10 years, as required to be reported in the Annual Financial Report.

Regional Connectivity Program

Council endorsed a letter of support being provided to CRISP Wireless, for their application under the Regional Connectivity Program to improve telecommunications connectivity in the Wheatbelt.
