Restricted Burning Period

The Prohibited Burning Period finished on 14 February 2019 and the Restricted Burning Period commenced.

Restricted Burning Period

- 15 February to 29 March (inclusive).
- Permits to burn are required during this period.
- Contact a Fire Control Officer for your respective brigade to obtain the permit required.
- Permit conditions as per the Shire of Pingelly Bush Fire Control Order and must be followed.

If there are no significant rain events before 29 March 2019 the Restricted Burning Period will be extended through to 12 April 2019. Permits to burn required during this period. Please be aware that due to the very dry conditions and the unpredictable windy days that we have had this season the issue of a burning may not be granted.

Community Grants 2019/20

CLOSE FRIDAY 29 MARCH 2019

This is an excellent opportunity for local community groups, clubs and organisations to secure some funding. All applications must be submitted to the Shire office by 29 March 2019 to be considered. Once all applications are assessed they will be put to Council for consideration in the 2019/20 financial budget. Once this process is completed you will be notified of the outcome in the form of a letter as per the Community Grant Scheme guidelines.



Please note the funding policy guidelines that if your application is successful Council's contribution will generally be limited to one third of the total project value up to \$5,000. Each application needs to outline matching in kind or matching funding to support your application.

Grants are generally paid on submission of receipts and evidence of project completion. This may be varied by prior agreement with Council.

Works Update

- The Parks and Gardens Team have been carrying out town maintenance.
- Backfilling of kerbing has been completed this week. Some additional signage has been ordered as part of Main Roads review of the line marking plan. Line marking will be scheduled by Main Roads when contractors are available. Motorists are advised traffic management will be on site and to follow signage and speed limits set.
- Road reconstruction work on a section of York Williams Road between North Wandering Road and Ulbrich Road with gravel being carted to widen the road to a ten meter formation. Motorists are advised traffic management will be on site and to follow signage and speed limits set.
- Maintenance grading has been carried out on Overington and Jingaring Roads.
- Repairs have been carried out to the loading ramp opposite the Roadhouse after the hay fire last year.
- WANDRRA funded drainage repairs have been carried out on the open drain on Stratford Street from storm damage in 2017.
- Traffic hazard signage has been erected on Aldersyde Road east of Powell Road to warn motorists of a road failure. Repairs will be carried out when a crew is available.
- Soil has been trucked into the landfill to provide cover for the domestic rubbish.
- Maintenance work continuing on CEO residence, proposed date for internal painting is 2 April 2019.
- Road inspection and gravel sampling has been undertaken on Milton Road in preparation for gravel resheeting planned for July 2019. This work will be part of the proposed Regional Road Group (RRG) capital works program for 2019/20.
- New mower purchased for Shire Oval to replace the existing 30-year-old mower.
- Sand pad constructed for new water tank for the PRACC Bowling Green.
- Water cooler to replace faulty water cooler at PRACC has been installed.
- Minor building maintenance issues sorted.
- Graffiti at Pioneer Park toilets removed.

Further information

- Maximum of \$150 per child per calendar year.
- \$150 can be split over multiple clubs.
- Fees are only for the nominated registered season.
- No retrospective fees will be paid.
- No limitation to the number of applications per family, providing the criteria for each child is met.
- Applicants can only receive KidSport funding for a financial exception once.



KidSport financial exceptions

If applicants are not listed on a valid concession card they can apply for a KidSport financial exception through a financial assessor.

Who are KidSport financial assessors?

KidSport financial assessors are professional employees at agencies who provide support services for families. They will assess a family's financial situation against the KidSport financial exceptions and submit a KidSport application on their behalf. The department will review and assess the application.

Financial exceptions

- 1 Sudden loss of employment and subsequent income from the main income earner of the family. This does not include voluntary unemployment or circumstances where a redundancy payment has been received.
- 2 Death or serious illness of a parent/guardian causing significant impact on the household income.
- 3 Fire, flood or other natural disaster causing significant impact on the household's financial situation.
- 4 Situations where the child has been placed into care (of the State, foster or extended family) and the relevant concession cards are unavailable.

Welcome to KidSport!

Sport helps you step up and gives you confidence to become part of a team, make friends and kick goals. Sport is great practice for life on and off the playing field. It builds stronger, healthier, happier and safer communities and should be part of every child's life regardless of their circumstances, ability or where they come from.

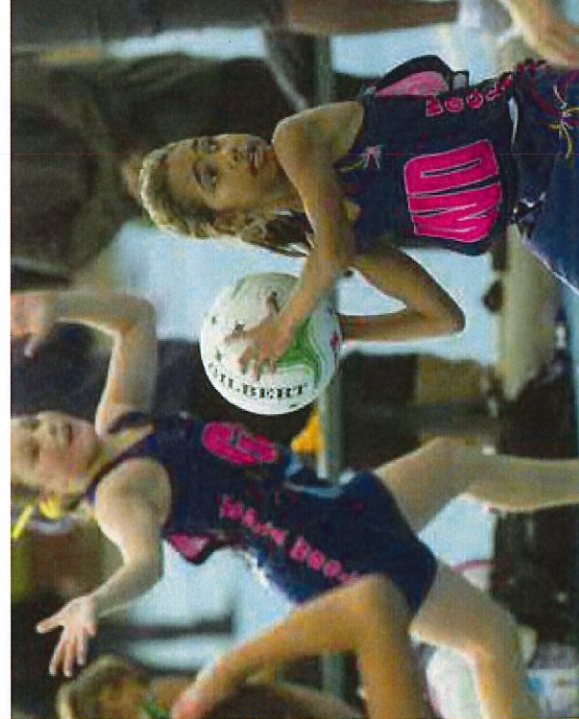
Active children are more likely to be active adults. Sport is fun, but just as importantly, participation gives your child a better chance of doing well at school, improves coordination and balance, helps them sleep better, improves social and life skills and creates a greater sense of wellbeing. When kids play sport, the whole community wins.

What is **KidSPORT**?

KidSport enables eligible children in Western Australia, aged 5-18 years old, to participate in community sport by offering them financial assistance towards club fees.

Eligibility criteria

- Applicants must be aged 5-18 years.
- Applicants must be listed on a valid Health Care or Pensioner Concession card issued by Centrelink.
- Applicants must reside in Western Australia.



How do I get involved?

Applicants listed on a valid Health Care or Pensioner Concession Card can apply online, on the KidSport website www.dsr.wa.gov.au/kidsport.

- Applications are assessed within 10 working days and if approved your code will be emailed to you.
- Voucher codes should be submitted to the club. Clubs can then claim their funding through their online portal.
- Vouchers expire after 90 days.

Applicants who are not listed on a valid concession card but meet one of the KidSport financial exceptions can apply for KidSport by contacting a financial assessor.
