## Shire of Pingelly Waste Facility

The Shire of Pingelly would like to remind residents that the Pingelly waste facility is open Friday—Monday 7.30am—4.30pm. To gain entry to the facility, you will require your 2019/20 tip pass, which were distributed with the recent rates notices.

## Works Update

- Gravel sheeting work has commenced on Milton Road between Bullaring Road and Woyerling Road. Motorists are advised this section of road will be closed during work hours except for local traffic
- Work to replace the timber bridge structure at Bridge No 3097 on Bullaring Road with concrete box culverts has been completed. Width markers and delineators are to be installed next week. Once that has been done the road will then be opened. Motorists are advised the gravel side track is open and to follow signage and speed limits set. This work is fully funded by Main Roads WA for Shires that have a compliant bridge maintenance program.
- Traffic hazard signage is in place on Aldersyde Road, east of Powell Road to warn motorists of a road failure. Work to repair the failures is being scheduled now and is expected to be completed in September.
- Winter maintenance grading work has been carried out on Ford, Bassendean and Moorumbine Roads.
- Storm damage repair work on Jingaring Road has been completed. Five roads on the western side of Pingelly still need drainage repair work done to finalise the WANDRRA claim.
- Minor building maintenance repairs have been carried out.
- Traffic counters have been installed on Avery South, Bassendean and Gillett Roads.

## Rav Network 4 access

Walwalling Road has been deemed suitable for RAV Network 4 access with the following conditions:  
4230019 Walwalling Road

- Low Volume Type A conditions
- Maximum speed 60km/h
- Headlights must be switched on at all times
- When travelling at night, the RAV must travel at a maximum speed of 40km/h and display amber flashing warning light on the prime mover.
- Direct radio contact must be maintained with other restricted access vehicles to establish their position on or near the road (suggested UHF channel 40)

# Shire of Pingelly

## Electoral Roll

### Information

The **Shire of Pingelly Electoral Roll** is comprised of two parts; the **Residents Roll** and the **Non-Resident Owners and Occupiers Roll**.

The **Residents Roll** is maintained by the Western Australian Electoral Commission. People who reside in the Shire (irrespective of whether they own the property or are tenants), and who are on the State Electoral Roll, will be on this roll automatically and can vote in Shire of Pingelly elections. No separate enrolment for the Shire of Pingelly is necessary. **Enquiries about this roll should be directed to the Western Australian Electoral Commission on 13 23 26.**

The **Non-Resident Owners and Occupiers Roll** is maintained by the Shire of Pingelly. This is comprised of individuals who own (but do not reside in) or occupy rateable property in the Shire and of individuals nominated by companies that own or occupy rateable property in the Shire. Each person applying to go onto this roll must be on the State or Commonwealth Electoral Roll and must reside outside of the Shire of Pingelly local government district. If applying as an occupier, the person must have a right of continuous occupation of that property for at least three months from the date of application. The applicant is not required to provide proof of this in the first instance.

#### **1. When property is owned:**

- Each rateable property may provide up to two owners or owner nominees on the roll.
- If a property is owned by an individual person, that person may enrol. Where a property is owned by two or more persons, two of the owners may enrol, (with the written agreement of a majority of the owners where there are three or more owners).
- Where a property is owned by a corporate body, the corporate body may nominate one or two people to go onto the roll.
- An individual may only enrol once regardless of the number of properties owned, and a corporate body may only nominate two people onto the roll regardless of the number of properties owned in the Shire of Pingelly.
- An owner remains on the roll until the property is sold or in the case of owner nominees, either until the property is sold or the corporate body changes its nominees.

#### **2. When property is occupied:**

- Each identifiable portion of rateable property that is occupied may provide up to two occupiers or occupier nominees on the roll.
- Where an individual occupies the property he or she may enrol. Where two or more individuals jointly occupy a property up to two of them may enrol (with the written agreement of a majority where there are three or more co-occupiers).
- A corporate body that occupies property may nominate up to two people to go onto the roll.
- An individual may only enrol once regardless of the number of properties occupied and a corporate body may only nominate two people regardless of the number of properties occupied in the Shire of Pingelly.
- Occupiers and occupier nominees remain on the roll for two elections after their enrolment is accepted and then are taken off the roll six months after the second election. They must then re-enrol if they wish to continue as electors.

Individuals or corporate bodies may only be on the roll or represented on the roll in one capacity, that is, either as owners or occupiers. Where both capacities are available to an individual or a body corporate, the owner category would normally be chosen because of the longer term on the roll.

Enrolment claims for either the Residents Roll or the Non-Resident Owners and Occupiers Roll can be lodged at any time. Enrolments for the upcoming election on Saturday 19 October 2019 close at **5pm Friday 30 August 2019.**
