**FI401****FISH RESOURCES MANAGEMENT ACT 1994****WEST COAST ROCK LOBSTER MANAGED FISHERY MANAGEMENT PLAN AMENDMENT 2025**

A35033

Made by the Minister under section 54.

**1. Citation**

This instrument is the *West Coast Rock Lobster Managed Fishery Management Plan Amendment 2025*.

**2. Management plan amended**

The amendments in this instrument are to the *West Coast Rock Lobster Managed Fishery Management Plan 2012*.

**3. Commencement**

These amendments come into operation as follows—

- (a) clauses 1 and 2—on the day on which this instrument is published in the *Gazette*;
- (b) clauses 4 and 9—on 1 July 2025;
- (c) the rest of the clauses—on the day after publication day.

**4. Clause 13 amended**

In clause 13 delete subclause (1) and insert—

- (1) The capacity of—
  - (a) Zone A of the Fishery for the period commencing on 1 July 2025 and ending on 30 June 2026, is 1,224,000 kilograms (whole weight) of rock lobster;
  - (b) Zone B of the Fishery for the period commencing on 1 July 2025 and ending on 30 June 2026, is 2,176,000 kilograms (whole weight) of rock lobster;
  - (c) Zone C of the Fishery for the period commencing on 1 July 2025 and ending on 30 June 2026, is 3,400,000 kilograms (whole weight) of rock lobster.

**5. Clause 43 amended**

In clause 43 delete subclauses 43(4) and 43(4a) and insert—

- (4) Where a master consigns rock lobster to a registered receiver and the net weight determined by the master is not the same as the net weight determined by the registered receiver, the higher net weight is to be taken to be a quantity of rock lobster taken under the authority of the licence.

**6. Clause 62 amended**

(1) Delete subclauses 62(7) and 62(8) and insert—

- (7) Where a registered receiver takes possession of a consignment of rock lobster at a place other than the registered receiver's premises, the registered receiver must—
  - (a) accurately weigh and determine the gross weight of the rock lobster to be transported immediately upon taking possession of the rock lobster; and
  - (b) subject to paragraph (a), immediately and accurately complete Part B of a registered receiver consignment form in respect of that consignment; and
  - (c) determine the net weight of the consignment in accordance with Schedule 10 after the arrival of the consignment at the registered receiver's premises; and
  - (d) accurately complete Part C of a registered receiver consignment form in respect of that consignment immediately after determining the net weight of the consignment.
- (8) Where a registered receiver takes possession of a consignment of rock lobster at the registered receiver's premises, the registered receiver must—
  - (a) immediately and accurately weigh and determine the gross weight of the rock lobster; and
  - (b) not less than 10 minutes after determining the gross weight of the consignment, accurately weigh and determine the net weight of the rock lobster in accordance with Schedule 10; and
  - (c) immediately and accurately complete Part C of a registered receiver consignment form in respect of that consignment.

(2) Delete subclauses 62(9) and 62(10) and insert—

- (9) A registered receiver must, within 48 hours of taking possession of a consignment, forward the completed original of the registered receiver consignment form to the Department at the address specified on the form.

**7. Clause 65 amended**

In clause 65 delete clause 65(1) and insert—

- (1) A person must not fish at any time in any of the areas of the Fishery described in—
  - (a) Schedule 5; or
  - (b) Schedule 11.

**8. Schedule 4 deleted**

Delete Schedule 4.

**9. Schedule 9A replaced**

Delete Schedule 9A and insert—

**SCHEDULE 9A—Fees**

[clause 12A]

For the purpose of calculating the total fee, the fee payable (per unit) for the grant or renewal of a licence for the period commencing on 1 July 2025 and ending on 30 June 2026 is—

- (a) for a Zone A unit, \$19.40;
- (b) for a Zone B unit, \$27.83;
- (c) for a Zone C unit, \$28.10.

**10. Schedule 10 replaced**

Delete Schedule 10 and insert—

**SCHEDULE 10—Method for the determination of container weights**

[clause 3]

- (1) Method for determining container weight
  - (a) Where container weight is to be determined by the master of an authorised boat, the containers and all lids and attachments must be—
    - (i) cleaned and emptied immediately prior to being weighed;
    - (ii) completely submerged in water for 10 minutes;
    - (iii) removed from the water and placed on a flat draining surface for 10 minutes;
    - (iv) shaken; and
    - (v) immediately weighed.

- (b) Where container weight is to be determined by a registered receiver, the containers and all lids and attachments must be—
  - (i) weighed immediately after the rock lobster have been removed; and
  - (ii) be clean and empty immediately prior to being weighed.
- (2) Method for determining net weight of a consignment of rock lobster  
Net weight of a consignment is determined by subtracting the total weight of all containers in a consignment from the gross weight of the consignment.

MENTAL HEALTH ACT 2014

Made by the Chief Psychiatrist under section 525(e) of the *Mental Health Act 2014*;

1. Citation

Attempted suicide, which is—

- an incident involving deliberate self-inflicted bodily injury with the intention of ending the person’s life; and
- an incident which is considered a near miss where the incident may have, but did not cause harm, either by chance or through timely intervention, including but not limited to self-poisoning, overdose, hanging.

Attempted suicide does not include suicidal ideation which the person has not acted upon.

2. Commencement

This order comes into operation on the day on which this order is published in the *Gazette*.

LOCAL GOVERNMENT ACT 1995

Shire of Pingelly  
SAVE THE NUMBATS LOCAL LAW 2025

Under the powers conferred by the *Cat Act 2011*, the *Local Government Act 1995* and all other powers enabling it, the Council of the Shire of Pingelly hereby records having resolved on 16 April 2025 to adopt the following local law—

PART 1—PRELIMINARY

1.1 Citation

This local law may be cited as the *Shire of Pingelly Save the Numbats Local Law 2025*.

1.2 Commencement

This local law will come into operation on the fourteenth day after the day on which it is published in the *Government Gazette*.

1.3 Shire of Pingelly Cats Local Law 2024 repealed

The *Shire of Pingelly Cats Local Law 2024* published in the *Government Gazette* on 14 June 2024 is repealed.

1.4 Shire of Narrogin Cats Local Law 2016 adopted

The text of the *Shire of Narrogin Cats Local Law 2016* published in the *Government Gazette* on 8 August 2016, as amended by the *Shire of Narrogin Repeal and Amendment Local Law 2021* published in the *Government Gazette* on 6 January 2022, is adopted as a local law of the Shire of Pingelly subject to the modifications set out in Part 2 of this local law.

PART 2—MODIFICATIONS

2.1 Clause 1.1 amended

Clause 1.1 is amended by deleting the words “*Shire of Narrogin Cats Local Law 2016*” and inserting the words “*Shire of Pingelly Save the Numbats Local Law 2025*”.

2.2 Clause 1.4 amended

- (1) Clause 1.4 is amended as follows—
- (a) amend the definition of “**local government**” by deleting the words “Shire of Narrogin” and inserting the words “Shire of Pingelly”.

2.3 Clause 2.1 amended

- (1) Clause 2.1 is amended as follows—
- (a) delete sub-clauses (2), (3), and (4);
- (b) renumber sub-clauses (5) and (6) to (2) and (3) respectively.

**2.4 Clause 3.2 amended**

(1) Clause 3.2 is amended as follows—

- (a) delete sub-clause (2); and
- (b) insert a new sub-clause (2) as follows—

“(2) No more than 2 cats may be kept on any premises for the purpose of regulation 6 of the *Cat (Uniform Local Provisions) Regulations 2013*.”

**2.5 Clause 3.3 amended**

(1) Clause 3.3 is amended as follows—

- (a) delete sub-clauses (a) and (b);
- (b) insert a new sub-clause (a) as follows—

“(a) keep more than 2 cats over the age of 6 months and the young of those cats under that age;”, and

- (c) renumber sub-clauses (c) and (d) to (b) and (c) respectively.

**2.6 Clause 4.5 amended**

Clause 4.5 is amended by deleting the words “clause 3.3(c) or (d)” and inserting the words “clause 3.3(b) or (c)”.

**2.7 Clause 4.7 amended**

Clause 4.7 is amended by deleting the words “clause 3.3(c) or (d)” and inserting the words “clause 3.3(b) or (c)”.

**2.8 Schedule 1 amended**

(1) Schedule 1 is amended as follows—

- (a) delete the words “Shire of Narrogin” and insert the words “Shire of Pingelly”;
- (b) delete the words “clause 3.3(c)” and insert the words “clause 3.3(b)”; and
- (c) delete the words “clause 3.3(d)” and insert the words “clause 3.3(c)”.

**2.9 Schedule 2 amended**

Schedule 2 is amended by deleting the words “Shire of Narrogin” and inserting the words “Shire of Pingelly”.

**2.10 Schedule 3 amended**

(1) Schedule 3 is amended as follows—
