Works Update

 Gravel sheeting work will be completed on Milton Road between Bullaring Road and Woyerling Road on Friday the 6th of September. The gravel sheeting has experienced some delays due to recent rain. Motorists are advised this section of road will be closed during work hours except for local traffic.



- Stabilising work to repair road failures on Aldersyde Road is scheduled to start on Monday the 16th of September and should be completed by late September. Motorists are advised traffic management will be on site and to follow signage and speed limits set.
- Winter maintenance grading work has been carried out on Shaddick, Stewart, Hastings, Aldersyde and Jingaring Roads.
- Storm damage repair work on Jingaring Road has been completed. Five roads on the western side of Pingelly still need drainage repair work done to finalise the WANDRRA claim.
- Traffic counters have been installed on Avery South, Bassendean and Gillett Roads.
- Roadside shoulder and verge spraying has been carried out on North Wandering, York-Williams, North Bannister and Napping Pool Roads.
- A repair has been carried out to a broken reticulation pipe on the oval.
- Planning for the Wickepin Pingelly Road project has commenced.

CSRFF Application for Construction of Two Cricket Practice Nets

Summary:

Council to consider endorsing the proposal to submit a funding application to the Department of Local Government, Sport and Cultural Industries (DLGSCI) for the Community Sporting Recreation Facilities Fund (CSRFF) small grants 2020/21 funding round.

Recommendation and Council Decision:

That Council

•Endorse the submission of a Community Sporting & Recreation Facilities Fund grant application for the Construction of Two Cricket Practice Nets Project;

•Give the Construction of Two Cricket Practice Nets Project a priority ranking of 1;

•Rate the Construction of Two Cricket Practice Nets Project as "A - Well planned and needed by municipality"; and

•Confirm the financial commitment of \$23,333.33 for the construction of two cricket practice nets, as listed in the Shire of Pingelly 2019/20 Annual Budget.

Proposed Dome Shelter for Public Outdoor Area
