Dog and Cat Registration Renewals

The Shire of Pingelly Dog and Cat registration renewals have been posted. Please note they are due to be paid by 31 October 2018. If you have not received your renewal form by the end of the week please give the office a call or come in to see us to check your contact details are current. If you receive a renewal for an animal you no longer have please let us know so the Shire records can be updated.

The Dog Act 1976 requires all dogs over three months of age to be licensed. Dogs must be microchipped before they can be registered. Your rights and responsibilities as a dog owner are outlined in the following link - https://www.dlgc.wa.gov.au/AdviceSupport/Pages/Cats-and-dogs.aspx. See below for licensing fees. The Cat Act 2011 requires all domestic cats that have reached 6 months of age to be microchipped, sterilised and registered with the relevant local government. Cats are required to wear a collar and registration tag to ensure that owned cats can be easily identified and returned to their owner.

Next Rates Instalment Due

Please note that the second rates instalments are due on the 28th October 2019.

2019/20 Fire Season

The Restricted Burning Period commenced on 19 September and will run until 31 October inclusive. Permits must be obtained during this period.

To ensure that your property is compliant, all fire hazard reduction must be complete by 31 October 2019. If your property is non-compliant at the end of this period, infringements will be issued.

Please refer to the Fire Control Order that was issued with the Rates Notices or contact the Shire Office for further information.

Works Update

- Maintenance grading has been completed on Aldersyde, Dwarlarking, and Hickmott roads.
- Storm damage repair work has been completed on Napping Pool and Walwalling Roads to finalise the WANDRRA claim.
- Verge clearing has commenced on Zig Zag Road as part of the Commodity Route Funding Program. The road will be closed to all but local traffic only. Traffic management will be on site and motorists are advised to follow signage and speed limits set.

- The entrance to aviation street has been cement stabilised to help stop trucks from scuffing out the gravel when turning
