Shire of Pingelly Extraordinary Election Information

- Close of electoral rolls is 5pm on Thursday 28 November 2019—this means if you would like to nominate to become a Councillor, or if you would like to vote at the election your name MUST be on the electoral roll by this date. You can check your enrolment by visiting: https://www.wa.gov.au/service/justice/administrative-law/check-your-electoral-enrolment
- Nominations for Council open at 8.30am Wednesday 4 December and close at 4pm on Wednesday 11 December 2019.
- If more than one nomination is received, voting will commence on Thursday 12 December 2019 and run until 4pm Thursday 16 January 2020 (the day before election day) at the Shire Office.
- Election Day—Friday 17 January 2020—voting from 8am to 6pm at the Shire Office.

Both absent and postal voting will be available if you will be away during the voting period or cannot attend the Shire office to lodge your vote.

Works Update

- Maintenance grading has been done on Welshman Road and Chopping Road.
- Parks and gardens are continuing to slash and whipper snip winter weed growth from town drains and open areas.
- Gravel sheeting on Zig Zag Road continues with all the gravel expected to be placed on the road by Friday 15th of November. The grader and water trucks are following behind water binding .traffic management is still in place and the road is still closed to all but local traffic.

Shire of Pingelly Extraordinary Election Friday 17 January 2020 ENROLLING TO VOTE

You may be eligible to be enrolled to vote in the following in-person Local Government Extraordinary Election for the Shire of Pingelly on Friday 17 January 2020 if you live in or are an owner or occupier of rateable property in the district of the Shire of Pingelly.

Residents

You are automatically enrolled to vote if you are on the State Electoral Roll as a resident of the Shire of Pingelly as at 5.00pm on Thursday 28 November 2019. If you are not already on the State Electoral Roll but meet the eligibility criteria for this roll, a claim for enrolment can be made to any Divisional Returning Officer of the Australian Electoral Commission in Western Australia.

Forms are available from all post offices or the Western Australian Electoral Commission and must be completed and reach a Divisional Returning Officer by 5.00 pm on Thursday 28 November 2019.

Non-Residents Owners and Occupiers

If you are a non-resident owner or occupier of rateable property in the Shire of Pingelly and are on a State or Commonwealth Electoral Roll you are eligible to enrol to vote.

If you are not on the State or Commonwealth Electoral Roll and own or occupy rateable property in the Shire of Pingelly you may be eligible to enrol to vote and should make an enrolment application to the Shire of Pingelly. If you are not on the State or Commonwealth Electoral Roll and own or occupy rateable property in the Shire of Pingelly, you may be eligible to enrol to vote. Please contact the Shire for details. Owners of land who were on the last Shire roll continue to retain that status until they cease to own the rateable properties to which the enrolment relates.

Occupiers do not have continuous enrolment and should contact the Shire to confirm their enrolment status. To be eligible to enrol as an occupier you will need to have a right of continuous occupation under a lease, tenancy agreement or other legal instrument for at least the next three months following the date of the application to enrol.

Joint Owners and Occupiers

If a rateable property is owned or occupied by more than two people, a majority of the owners/occupiers may nominate two persons from amongst themselves who are on either the State or Commonwealth electoral roll, to enrol as owner/occupier electors.

Corporations

A body corporate that owns or occupies rateable property may nominate two people who are on either the State or Commonwealth Electoral roll, to enrol as owner/occupier electors.

Electoral Forms

Enrolment claim forms can be obtained from the Shire of Pingelly or Australian Electoral Commission offices and should be lodged with the Shire of Pingelly Chief Executive Officer by 5:00pm on 28 November 2019.
