Shire of Pingelly Extraordinary Election Information—last call for registration on the roll!

- Close of electoral rolls is 5pm on Thursday 28 November 2019—this means if you would like to nominate to become a Councillor, or if you would like to vote at the election your name must be on the electoral roll by this date. You can check your enrolment by visiting: https://www.wa.gov.au/service/justice/administrative-law/check-your-electoral-enrolment
- Nominations for Council open at 8.30am Wednesday 4 December and close at 4pm on Wednesday 11 December 2019.
- If more than one nomination is received, voting will commence on Thursday 12 December 2019 and run until 4pm Thursday 16 January 2020 (the day before election day) at the Shire Office.
- Election Day—Friday 17 January 2020—voting from 8am to 6pm at the Shire Office.

Both absent and postal voting will be available if you will be away during the voting period or cannot attend the Shire office to lodge your vote.

Works Update

- Parks and gardens are continuing to slash and whipper snip winter weed growth from town drains and open areas.
- The placement of gravel on Zig Zag road has finished. The crew are now waterbinding the last km, and are starting to tidy up road verges and adjacent properties that have been affected in the course of their works. The road is still closed to all but local traffic.
- Patching of roads is ongoing.
- Various weed growth is continuing to be removed from town streets.
- Fallen tree limbs have been removed from rural roads.
- The public are reminded that while driving around the oval they are to drive only on the roads provided and not to cut across the lawn as it is now affecting the growth of the grass and is forming wheel rut.
- Assessments for new school bus stops carried out.
