FEBRUARY COUNCIL DECISIONS

Town Hall Council resolved to undertake further consultation in relation to the future use of the Pingelly Town Hall. This consultation is expected to commence in March and be finalised in April.

Tourism Strategy The development of a Tourism Strategy was endorsed, which will clearly define the Shire of Pingelly's role in this important area. Community input will be an important factor in the development of the Strategy, with the opportunity for input commencing in May 2020.

Policy—Attendance at Events In accordance with new legislative requirements, the Council endorsed a policy which governs the attendance at all events by the Council and Chief Executive Officer.

Risk Management Framework and Policy The Shire's Risk Management Framework and associated Policy were both approved.

Budget Review A Budget Review as at 31 January 2020 was adopted, showing a positive financial position estimated as at 30 June 2020.

Policy—Misconduct, Fraud and Corruption The Policy was adopted by Council to ensure the Shire of Pingelly's risks in this area are controlled appropriately.

Subdivision Boundary Alignment A proposed subdivision at Lots 4387 and 5715 -391 Belt Road were supported.

DROUGHT COMMUNITIES PROGRAM

The Shire of Pingelly has been advised of the eligibility to apply for Federal Government funding under this program. The eligible activities include upgrading or building new community facilities or spaces, holding events, and undertaking other drought relief activities that benefit the whole community. This assessment criteria includes: increasing employment in the short and long term, improving levels of economic activity, and retaining businesses and services. Potential projects are currently being assessed against funding criteria to maximise the chance of success.

FEBRUARY WORKS

The Shire of Pingelly is commencing roadworks on the Yenellin Road, Harper & Bodey Streets intersection realignment from 20 February 2020 until further notice. The works include realigning Bodey Street to a T Junction with Harper Street / Yenellin Road and widening of a section of Yenellin Road. During this period there will be temporary road closures between the hours of 7.00am to 4.00pm at the following intersections. Traffic control measures will be in place, so please exercise caution while travelling in this area.

- No access to Bodey Street where Bodey Street intersects Sharow & Overhue Streets.
- No access to Yenellin Road from Pitt Street
- No access to Yenellin Road from Narducci Street

The position of Plant Operator is responsible for operating and maintaining trucks and other plant and machinery items to assist in the completion of road maintenance and construction projects. The role will also be required to regularly perform a range of labouring duties associated with road maintenance functions, including pothole repairs, signage maintenance and general maintenance of roads, roadsides, footpaths, kerbs, drainage, bridge structures and other assets.
